HEALTH CARE SUBSIDY PAYMENTS

Please note: When completing the forms required for the payment of the health care subsidy for the period of 2017 thru 2019, there is a question about whether you qualified during that period for Medicare coverage. If you received Medicare benefits at any point during the period 2017-2019, please check **yes** on the form. If you did not receive any Medicare benefits during the period of 2017-2019, please check **no** on the form.


The Fund will process two separate retroactive subsidy payments for each eligible member. One for the period of January 1, 2017 thru December 31, 2018 and a second payment for the period of January 1, 2019 thru December 31, 2019. Members should expect to receive the subsidy form for the period of January 1, 2019 thru December 31, 2019 next month.

Beginning with the January of 2020 benefit payments, eligible members will receive their healthcare subsidy payments as part of their regular monthly benefit payment.

ANNUITY ESTIMATES

Because the City's collective bargaining agreement with Local 2 has been expired for over 2.5 years, the Fund's ability to provide useful annuity estimates is limited. The reason for the limitation is the members' salaries have largely remained stagnant during this period. Until a new collective bargaining agreement is in place, the Fund will only be able to provide annuity estimates with a projected retirement date of December 31, 2021 or earlier.
