MONTHLY NEWS AND INFORMATION FROM YOUR RETIREMENT BOARD

YOUR RIGHTS UNDER THE ILLINOIS CONSTITUTION

ARTICLE XIII - GENERAL PROVISIONS - SECTION 5. PENSION AND RETIREMENT RIGHTS

Membership in any pension or retirement system of the State, any unit of local government or school district, or any agency or instrumentality thereof, shall be an enforceable contractual relationship, the benefits of which shall not be diminished or impaired.

ILLINOIS LEGISLATIVE UPDATE

Four bills passed out of the Illinois Legislature that have direct impact on the Fund. It is anticipated the Governor will sign each into law within the next thirty days.

- Senate Bill 4053 provides that beginning January 1, 2023, the minimum widow's annuity shall be no less than 150% (rather than 125%) of the Federal Poverty Level for all persons receiving widow's annuities on or after that date.
- Senate Bill 3177 retroactively amends the Code and provides that a fireman who withdraws before age 50 and a fireman with less than 10 years of service who withdraws before age 57 (instead of a fireman who withdraws with less than 10 years of service), or any fireman who withdraws and enters the service of another department of the city, has a right to a refund of the entire amount to his credit as of the date of withdrawal.
- House Bill 4435 provides that any active fireman who has completed 7 or more years of service and is unable to perform his or her duties in the Fire Department by reason of a contagious staph infection, including methicillin-resistant Staphylococcus aureus (MRSA), resulting from his or her service as a fireman, shall be entitled to receive an occupational disease disability benefit during any period of such disability for which he or she does not have a right to receive salary.

- Senate Bill 2952 is a provision concerning the board of trustees, provides that the City Treasurer, with the prior approval of the board, may also appoint a designee from among employees of the city who is versed in the affairs of the City Treasurer's office to act in the absence of the City Treasurer on all matters pertaining to administering the Article.

The Board and staff will update the members and address questions as these new provisions become effective under the Pension Code.

RETIREMENT SEMINAR

Our popular 'Retirement Seminar' is returning this Fall. A Saturday date in September or early October has been requested from the concierge team at Guaranteed Rate Field. A formal announcement will follow when the date and venue have been secured.

FEDERAL 'HELPS' BILL UPDATE

A proposed change to the Healthcare Enhancement for Local Public Safety (HELPS) Act could provide retired firefighters more tax relief. A bipartisan bill introduced to Congress would make it easier for public safety retirees to access a tax benefit for their healthcare insurance premiums, according to a press release from Rep. Abigail Spanberger (D-VA). Spanberger, a former police officer, and Rep. Steve Chabot (R-OH) are sponsoring the bill.

According to the lawmakers, the Wally Bunker HELPS Retirees Improvement Act would enact the following:

- Ensure that health insurance premiums, whether through the pension system or a third-party system, are tax deductible.
- Raise the tax credit from \$3,000 to \$6,000 to account for rising healthcare premiums.
- Ensure that stipends qualify for the income exclusion under IRS section 402(I).
- Help alleviate the burden imposed on public pension plans of having to interact and coordinate with numerous insurance companies on behalf of the related public safety retiree.

The Board and staff will monitor this legislation and keep our members updated as this bill progresses through the U.S. Congress.
